Nova Scotia's vegetable industry is an important contributor to the province's food supply with a diverse range of crops grown across the province. As part of Perennia's seven-person horticulture team, you will be at the front lines of exciting and impactful work that shapes the future of the horticulture industry provincially, regionally, and nationally. The Vegetable Specialist plays a key role in helping growers strengthen production practices, respond to challenges, and continue supplying high-quality vegetables to Nova Scotians.

This can be a hybrid home-office-field position with the understanding that candidates are required to be present regularly in Kentville and responsible for working with team members and client's province-wide.
